Historic Political Shift:

- ∨ The new government represents a significant political transformation in Sri Lanka, breaking decades of dominance by two main camps.
- ∨ This is the first time a single mandate has garnered broad support across all provinces and communities.

Commitment to National Unity:

- ∨ The government pledges to eliminate racism and religious extremism, acknowledging past divisions and their devastating impact.
- ∨ Emphasis is placed on fostering national harmony, ensuring a future free of ethnic and religious conflict.

Strengthening Democracy and Accountability:

- ∨ The government values multi-party democracy and aims to serve all citizens, regardless of political affiliation.
- ∨ Parliament will be restructured to regain public trust, ensuring transparency, accountability, and relevance.

Restoring Rule of Law and Justice:

- ∨ Commitment to enforcing the law without favoritism, addressing controversial crimes, and combating corruption.
- ∨ The government promises to rebuild public trust in the legal system and ensure justice for victims of past injustices.

Economic Stabilization and Growth:

- ∨ Plans to stabilize the economy through IMF agreements and comprehensive debt restructuring by the end of 2024.
- ∨ A three-pillar economic strategy focuses on increasing production, integrating people into the economy, and ensuring equitable wealth distribution.

Sectoral Focus for Rapid Growth:

- v Tourism: Aims to attract 4 million tourists and generate USD 8 billion within three to four years.
- v Information Technology: Plans to grow IT exports to USD 5 billion and increase professionals to 200,000 by 2029.
- v Agriculture and Fisheries: Transform these sectors into profitable ventures through subsidies, research, and market integration.

Transformational Initiatives:

- v Digitalization: Aims to create a USD 15 billion digital economy, with plans for a “Digital Sri Lanka.”
- v Clean Sri Lanka: A societal transformation project to foster good citizenship, environmental responsibility, and humane values.

Poverty Eradication and Social Welfare:

- v Increased welfare allowances, pensions, and support for vulnerable groups like differently-abled individuals.
- v Focus on creating economic opportunities and developing rural and urban economies.

Global Market Expansion:

- v Reforming diplomatic services to support Sri Lankan industries and entrepreneurs in accessing international markets.
- v Developing value-added industries for mineral resources and other unique products.

Budget and Governance:

- v A detailed budget aligning with the government’s transformative vision will be presented by early 2025.

Interim provisions will address immediate needs.

Collaborative Governance:

A call for unity across political camps to achieve a common goal: building a prosperous, just, and humane society.

President Dissanayake concluded with an appeal for unity and compassion, quoting Martin Luther King Jr.: “Darkness cannot drive out darkness; only light can do that. Hate cannot drive out hate; only love can do that.”

He urged Parliament to work together to transform Sri Lanka into a nation defined by justice, peace, and progress.
