Dr Chris Nonis, Trustee and Council Member of the Royal Commonwealth Society
Headquarters in London, which oversees the work of the Royal Commonwealth
Society in 53 Commonwealth countries, was elected as its Deputy-Chairman in
2008. Dr Nonis has the distinction of being the first Sri Lankan in the 140-year
history of the Royal Commonwealth Society, London, to be elected to this pivotal
international role.

Founded in 1868, the Royal Commonwealth Society continues to be a forum for
debate, advocacy, and promotion of shared Commonwealth values and principles. It
remains a strong protagonist for change within the Commonwealth. The Society
also provides an important forum for Heads of Government, Ministers, Diplomats,
and Academics, to speak on compelling Commonwealth imperatives. As one of the
foremost Commonwealth Institutions, the Royal Commonwealth Society has hosted
over 40 Heads of Government, including Lee Kuan Yew, Mahathir Mohammed, and
notably Nelson Mandela gave his first press conference at the Royal Commonwealth
Society following the end of the apartheid era in South Africa.

Dr Chris Nonis is the Chairman of the Mackwoods Group of Companies, having
succeeded his mother, the late Mrs Sriyani Nonis, in July 2005. Mackwoods,
established in 1841, is the second oldest mercantile establishment in Sri Lanka, and
is today a conglomerate of several companies engaged in key sectors of the Sri
Lankan economy, namely Healthcare (Pharmaceuticals, Medical Equipment,
Scientific & Lab Equipment); Agribusiness and Plantations (Tea, Rubber and Oil
Palm); ICT Education and Software Development; Imports and Exports; Industrial
Machinery and Equipment; Industrial Chemicals; Energy Sector; Leisure Sector; and
Manufacturing Sector, providing employment to nearly 9500 individuals, and
managing a land base of over 27,000 acres.

Dr Nonis qualified in London, with a First Class Honours Bachelor of Science degree
from Imperial College of Science, Technology and Medicine; obtained his MBBS from

the Royal Free Hospital Medical School, University of London, having completed his electives at Massachusetts General Hospital, Harvard Medical School, Boston, USA. Dr Nonis carried out his postgraduate training at Royal Brompton, the Hammersmith, and Addenbrooke's Hospital, Cambridge and obtained his Membership of the Royal College of Physicians, MRCP. (UK).

Dr Nonis is a Director of the National Enterprise Development Authority (NEDA) and serves on the Grants Board of the ICT Agency of Sri Lanka (ICTA). Furthermore he holds numerous positions including serving the National Advisory Council for Export Development of the EDB (NACFED); Vice Chairman of the Services Group of the Employers' Federation of Ceylon; the Advisory Committee on Peace & Reconciliation of the Ceylon Chamber of Commerce; the Country Coordinating Mechanism for Sri Lanka of the Global Fund; Chairman of the Advisory Committee on Spices & Allied Products of the Sri Lanka Export Development Board; and President of the India Life Sciences Institute – Sri Lanka Committee. He is a Fellow of the Royal Society of Medicine, London and has been an advisor to the World Health Organization, Geneva.
