The Bank will also initiate the initial coordination between local exporters and identified global buyers while providing export advisory services (EAS), and financial assistance in pre-shipment, post-shipment, and project loan areas and will also frequently review the program's progress with the EDB.

The EDB will provide advisory services by assisting entrepreneurs in selecting appropriate export businesses by understanding the global demand and using locally sourced resources. EDB will also conduct training programs and seminars to provide entrepreneurs and investors with the required knowledge of the export market.

Additionally, the EDB will also assist in paving the path to integrating local exporters and global buyers through coordination with respective embassies when seeking buyers and will also facilitate local participation in international trade shows and exhibitions. During the program, entrepreneurs Dr. Lasantha Malavige, Anuruddha Wijerathna, and Dilantha Malagamuwa made presentations sharing their success stories with the participants.
