## Spanish Investor To Build Hotel Resort At Yala

The Board of Investment (BOI) of Sri Lanka signed an agreement with Putus Brothers Sustainable Developments to build, construct and operate a 15 cabana Hotel Project in Palatupana, Yala

The agreement was signed on behalf of BOI Sri Lanka by Anil Amarasuriya, Board Member and Acting Chairman and Dr Nihal Samarappuli, Board Member and Narcis Clavell and Jagath Wickramage, Directors for Putus Brothers Sustainable Developments. The total value of the project will be 1.6 million US dollars. The project will consist of 43 luxury cabanas in Yala.
